RIP RBG! She was a courageous, powerful woman who made great strides toward equality for women. Here is a testimonial from the National Women’s Hall of Fame written before her passing. “Justice, justice, thou shalt pursue,” the Old Testament words Justice Ruth Bader Ginsburg keeps on the wall of her chambers, epitomize the outlook and achievement of this distinguished jurist. Ginsburg has worked her entire career to eliminate gender-based stereotyping in legislation and regulations. Appointed Associate Justice of the United States Supreme Court by President William Clinton in 1993, she is the second woman to sit on the bench of the United States Supreme Court in its 212 year history.” Additionally, there have been 114 U.S. Supreme Court Justices and only four have been women.

Be sure to Vote in the November 3rd Elections! Refer to the County of Sonoma’s website for accurate voting requirements and information at: sonomacounty.ca.gov/CRA/Registrar-of-Voters/Elections/November-3-2020-Presidential-Election/. The PJC endorses a Yes Vote on Measure P (a.k.a. Evelyn Cheatham Effective IOLERO Ordinance) which, “will bring greater transparency and accountability without raising your taxes or cutting the Sheriff’s budget” amongst other positive action steps as per the campaign synopsis.

The protests condemning police brutality continue non-stop around the country with peaceful protestors using leaf-blowers and umbrellas to protect themselves from the toxic and immoral use of tear-gas launched by law enforcement. Sparked by the horrendous

public lynching of George Floyd on May 25 in Minneapolis, and rekindled by the Grand Jury verdict on September 23 relieving the Louisville Police Department from any wrong doing in the shooting of Breonna Taylor while sleeping in her home, the protests show no sign of stopping until justice prevails.

Unprecedented is certainly the theme of 2020 thus far. We sincerely hope everyone is safe during these challenging times with the unhealthy air quality, massive wildfires and earthquakes over much of the Pacific Northwest. As a dear friend used to say, “If you are aware, you can prepare.” This is a great time to have an emergency plan in place; including, a grab-n’-go bag with a change of clothes, flashlight, enough food and water for 1-2 days, in the case of evacuation for any reason. Hopefully, in the event of a major disaster, most of us will be able to shelter-in-place and that is where we need to think about food, water and survival items for longer-term. There is a rise in homelessness in Sonoma County and elsewhere that seems untenable. Homeless Action! along with PJC, are seeking a safe space for a homeless man to park his trailer; reach out to us if you have such a place.

The Peace & Justice Center is still closed for meetings and events and currently, the office hours continue to be suspended as we work to comply with CDC and Sonoma County Health Department mandates regarding COVID-19. Protect Your Vote!

Most of us will be voting by mail this year. In a good year 22% of all mailed in ballots are never counted. 2020 is not a good year. There are steps you can take to protect your vote.

Make sure you are registered, even if you’ve voted at the same location for decades. Read and follow all the instructions on your ballot. In years past, ballots have been rejected because voters used the wrong color pen or

a pencil; stapled or taped their ballot closed, used their own envelope or checked their selection when instructed to fill in a bubble. Read and follow the instructions carefully. Fill out all the data. Try to vote early so if there are problems, you have time to fix them. Use early voting where you can.

All California voters will receive a mail-in ballot 29 days before the election or by October 5. You can mail in your ballot, drop it off at drop boxes, or drop it off at any polling place

within the county. Sonoma County voters can take it directly to the Board of Elections at 435 Fiscal Drive in Santa Rosa.

Two possible scenarios: Mail in votes take time to count and during this time it is possible that Trump’s storm troopers will riot and shut down vote counts (similar to 2000 in Florida, only with guns). Governors may not be able to verify their vote count and if no candidate receives 170 electoral votes, the

California State Proposition Descriptions

14. Authorizes bonds to continue funding stem cell and other medical research.
15. Changes tax assessment of commercial and industrial property, increasing funding for public schools, community colleges and local government services.
16. Repeals Proposition 209 Affirmative Action Amendment thus allowing state and local entities to consider race, sex, color, ethnicity & national origin in public education, employment & contracting.
17. Restores right to vote for persons on parole.
18. Allows voting in primary elections for 17-year-olds who will be 18 by the next general election.
19. Increases ability of seniors & other eligible homeowners to transfer tax assessments. Requires inherited homes that are not primary residences to be reassessed at market value. Net revenue goes to wildfire agencies & counties.
20. Restricts parole for non-violent offenders. Authorizes felony sentences for certain offenses currently treated only as misdemeanor.
21. Expands local government's authority to enact rent control on residential property.
22. Defines app-based transportation and delivery drivers as independent contractors and adopts labor and wage policies specific to app-based drivers and companies.
23. Authorizes state regulation of kidney dialysis clinics and establishes minimum staffing and other requirements.
24. Expands consumer privacy laws.
25. Referendum to overturn a 2018 law that replaced money bail system with a system based on public safety risk.

MEASURE P the Evelyn Cheatham Effective IOLERO Ordinance is On the November Ballot

Longtime members of the peace and justice community know that we have been working for many years for a more accountable Sheriff's Office through effective community oversight – first in the 1990's and later, after 13-year-old Andy Lopez was killed.

Sometimes, speaking up works and it just did in Sonoma County. Sometimes, the times are right for change and this might just be that time.

After Andy's killing by a sheriff's deputy, a partial victory was achieved with the County's creation of the Independent Office of Law Enforcement Review and Outreach (IOLERO). But the office was created without the tools to be effective – no subpoena power, no independent investigatory power, no requirement that the Sheriff's Office cooperate and not enough money to do the job.

After more than three years as Director of IOLERO, Jerry Threet wrote a revised ordinance to remedy these shortcomings. In writing it, he combined his experience on the job as well as his conversations with diverse groups in Sonoma County, the original, un-

fulfilled aspirations of the Community And Local Law Enforcement Task Force that created IOLERO, and the recommendations of the National Association of Community Oversight of Law Enforcement.

At the end of 2019, we began the usual signature gathering needed to put an ordinance on the ballot. With a deadline of May 2020, the efforts were cut short in March by the order to shelter in place. That led us to ask the Board of Supervisors to place the Evelyn Cheatham Ordinance on the November ballot. The original organizers were joined by activists energized in response to the killing of George Floyd and many other community members. We convinced the Board of Supervisors to place the ordinance on the ballot. As a result, you can now vote for a more effective IOLERO when you go to the polls in November.

Both our communities and deputies deserve the most effective and responsive Sheriff's Office possible. Modern law enforcement 'best practices' emphasize collaboration with communities and with independent, effective civilian oversight. Independent, effective

civilian oversight supports the democratic principles of accountability and transparency, and thereby increases trust between law enforcement and all communities. Also, many years of work across the country have gone into creating best practices policy for use of force, running a jail and so much more.

One of the stated goals of the County in creating IOLERO was to build greater trust between the community and the Sheriff's Office. Knowing that the deputies are employing best practices will foster that trust. The Evelyn Cheatham Effective IOLERO Ordinance – now Measure P – is an important step to building a Sheriff's Office the community can trust.

Those who favor the status quo have already begun lying about Measure P. They began by saying that backers failed twice to get the ordinance on the ballot. First, there weren't two attempts, only one, and second, being cut short by COVID-19 is hardly a "failure." The Sheriff also argues that deputies will be pulled off the streets and emergency response will be curtailed. None of this is true. His hope is that voters will conflate Measure P with the Defund movement. Defunding law enforcement is NOT on the ballot. The money for IOLERO does not come out of the Sheriff's budget.

The arguments made are so flagrantly false that they actually hinder the trust the Sheriff says he desires. The Sheriff's Office is used to operating in secret without accountability and they want to continue that way to the tune of millions of dollars in settlements, ever-escalating insurance premiums and far too many dead and injured victims of policing use of force. Measure P will save lives and money.

election will go to the House of Representatives as laid out in the 12th Amendment. Here each state will get one vote – and Trump can win this – America's final election. The 12th Amendment was used in the election of 1824.

Another possible scenario is that so many people come out to vote that even if they steal a million votes – like they did with Obama – they will not be able to steal the election. To do this we not only need to vote, but we need to

get those who don't usually vote to vote. With overwhelming numbers we can defeat Trump.

If you want to help, go directly to the polls and stop right wingers trying to challenge your right to vote. If they riot at voter counts – especially recall counts – physically stop them. If they use violence, we can't just say "oh my"; we need to confront them and stop them. This is important, because democracy matters. 🌱

Social and Racial Justice Action Organizations and Opportunities

"Please don't settle for happiness. It's not good enough. Of course you deserve it, but if that's all you have in mind – happiness – I want to suggest to you that personal success devoid of meaningfulness, free of a steady commitment to social justice – that's more than a barren life. It's a trivial one." – Toni Morrison

Delving into this question, "What to do about the state of our country so far off course, we don't know where to grab onto or begin?" has led to a plethora of fantastic work being done and opportunities abounding. Here is a synopsis of one person's search for promising opportunities for immediate participation and activation toward a world that works for everyone.

#8cantwait lists most American cities and where they stand on eight police practices. It calls for our police departments to ban chokeholds and strangulations, require de-escalation, require warning before shooting, require officers to exhaust all alternatives before shooting, impose a duty to intervene, ban shooting at moving vehicles, establish a use of force continuum and require comprehensive reporting. There are concerns about the methodology and data collection, but via that site a citizen can see where their city stands on each practice and can call on elected officials to support measured and restrained police behavior.

Cure Violence Global is ranked #9 in the top 500 NGOs in the world. Cure Violence stops the spread of violence by using the methods and strategies associated with disease control by detecting and interrupting conflicts, identifying and treating the highest risk individuals and changing social norms. Their website is <https://cvg.org/>.

End Cash Bail is a system that criminalizes poverty, as people who are unable to afford bail are detained while they await trial for weeks or even months. Cash bail perpetuates inequities in the justice system that are disproportionately felt by communities of color and those experiencing poverty. Many resources, sites and organizations exist to pursue this just and essential goal.

The Marshall Project is a nonpartisan, nonprofit news organization that seeks to create and sustain a sense of national urgency about the U.S. criminal justice system. It was formed about 10 years ago and named for Thurgood Marshall, the first African American justice to serve on the United States Supreme Court. Their website is <https://www.themarshallproject.org/>.

Defund the police sounds drastic but aims to reallocate or redirect funding away from police departments to other government agencies that are currently funded by local municipalities. Our justice and law enforcement systems are fatally flawed and need to be designed anew, thus the sparking of this movement. On the heels of the burgeoning Black Lives Matter movement has come a wave of Blue Lives Matter. There is a good deal of support and criticism of that coalition and its reason for being.

This month's Vanity Fair has an interesting article on this and a myriad of other contemporary race issues. Organizations and groups around the country are working on this reallocation of funding.

Invest in Community is any investment strategy which seeks to consider both financial return and social/environmental good to bring about social change. There are many choices and it is up to each individual to choose one.

Divest funds from harmful ventures like the American Legislative Exchange Council (ALEC). The Center for Media and Democracy explains that through the corporate-funded ALEC, global corporations and state politicians vote behind closed doors to rewrite state laws that govern your rights. These so-called "model bills" reach into almost every area of American life and often directly benefit huge corporations. ALEC is a major funder and sponsor of the industrial prison complex.

Save Our Streets is a division of New York City's Center for Court Innovation and "works to create a fair, effective and humane justice system." Their website is <https://www.courtinnovation.org/about>.

People's Safety Reimagined is a Cincinnati, Ohio Charter Amendment. Their website explains that, related to defunding the police, "There is a need for change in the way public safety is provided and that police do not keep people safe, nor has that ever been their job." Their program is based on the principles of refocusing, restructuring, retooling, reinvesting and rebuilding." However, it failed to get enough signatures for the city's November ballot. Their website is <https://psrecincinnati.org/>.

CAHOOTS in Eugene, Oregon stands for Crisis Assistance Out On the Streets. They rely on mental health professionals to respond to situations where they are best suited, rather than police response. Their website is <https://whitebirdclinic.org/cahoots/>.

Volunteer! It is a guaranteed way to contribute. Here's a favorite of mine:

clearings they have been doing, claiming that people are stealing power. Please note, *This is not an excuse to clear encampment without following the federal regulations in place to keep police brutality to a minimum.*

Activists are pointing out that the SRPD is blatantly ignoring Federal laws and health regulations that the Center for Disease Control (CDC) has put in place to prevent the spread of Coronavirus. They are destroying items they are supposed to store, their best offer for shelter is that piece of shit tent city this terrible air. They are literally kicking people off of sidewalks, which is ridiculous and inhumane.

Many high risk homeless people are still on the streets being ignored and they are dying. A woman well over 60 came in for lunch and she couldn't even stay awake to eat because she was so exhausted. We had to set up a place for her to rest after she asked if she could sleep in the dog bed!

Breaking down and setting up shelter everyday is not an easy task and sleeping outside

isn't either. SRPD doesn't care.

Another woman over 60 came in today who has emphysema and is in a wheelchair, but the chair is not allowed into Catholic Charity organizations for a ridiculous reason that I will keep private. She cannot breathe in healthy air and she is suffering endlessly in the smoke. Catholic Charities decides who they want to help and then they bully all of the other people on the streets.

No one is paying attention to high risk populations any longer. They are focused on cleaning the streets, as if we are going to be able to leave our shelters in the next few years. Coronavirus does not end with 2020. I am only one person and I am literally greeted by an avalanche of pain and

suffering every time I step outside. I know of many resources, but I also know that only a small group of people are actually making progress because now poverty is overwhelming and not limited to the homeless.

I am not looking for recognition or encouragement – the incredible guilt of not getting out of bed should keep me going a little while longer – but I need your help as a community. Please observe police interactions between people of color and the homeless (as a black woman I can tell you how much better it feels to have observers and how helpful it is if they call a supervisor on site). Call City Council and Board of Supervisors and demand low-income housing options in all neighborhoods

NOW. Start looking into Catholic Charities' budget and expose all of the corruption and their lack of empathy.

Pull your head out of your ass if you think you can constantly move the homeless problem around or because you think that they lower your property value.

Share this post. Come down to the kitchen if you have access to any resources at all and help people get inside. Write articles for the *Peace Press* (Dm for details). Advocate for budget cuts for the police – their salaries are more than triple mine and I deal with an immensely more dangerous environment every day. Vote Yes on Measure P. Vote Yes on Measure O. Investigate City Council candidates before the election and have conversations about their integrity and who fundraises them. Keep fighting every damn day. VRA – The Vehicle Ramming Attack

On July 14, 2016, Mohamed Lahouaiej-Bouhlel drove a lorry through a crowded promenade in Nice, France, swerving as he drove to inflict maximum damage. He killed 86 people in the attack, which introduced the world to a previously obscure form of terrorism known as the Vehicle Ramming Attack or VRA.

Our area’s first major protest this spring had a VRA by a 15-year old in a truck. It was only after snapchat messages where he said he wished he’d “killed all u f***ers” leaked, that public pressure forced police to reopen their investigation.

With this lax enforcement attitude, more attacks inevitably followed. On June 4, our home town of Healdsburg saw probably the largest protest in its history. Healdsburg Police were on high alert but apart from redirecting traffic they took little action. Then, on June 26, a follow-up protest took place. Led by high school student, Isabel Soto, it drew a smaller but still substantial crowd. HPD opted not to redirect traffic.

On Healdsburg Avenue, a white male who had been circling the demonstration aimed his truck at the center of the crowd and accelerated, swerving as he went, in a move chillingly reminiscent of the Nice attack. A few minutes later, a second driver swerved around the back of the march. Thankfully, everyone managed to jump out of the way, but in a group of mostly kids and seniors, it could easily have been much worse.

The first assailant, however, made the mistake of driving one of the most recognizable trucks in town, complete with a decal for his employer, a thin blue line decal and a vanity license plate based on his last name. After video was posted, he was quickly tracked down and identified online or doxed as Alex Zouzounis of Windsor.

In response to our questions about the investigation, Chief of Police Kevin Burke told Councilmember Naujokas in a July 2 email that Naujokas forwarded to us, “We are aware of social media claims by third parties who say they were told by witnesses that the trucks actually swerved at pedestrians, but no eyewitnesses are coming to us with that information, nor can we identify them through the social media postings. Some have also claimed to have video evidence, but then failed to follow through with providing that.”

There are several problems with this state-

ment. We spoke to at least two eyewitnesses who had made police statements or reports, one of whom had also sent them her video of the incident. That same day, the front page of the *Tribune* featured an article by Katherine Minkiewicz that began, “A white pickup truck aggressively swerved through a crowd of about 50 protesters... during a youth anti-racism march.” It goes on to state, “Multiple people reported the incident.”

Chief Burke was either unfamiliar with the facts of the case or considered most forms of evidence inadequate. But thanks to public pressure, HPD eventually recommended charges for both drivers to the District Attorney.

But the police *can* use social media for investigations. We know this because after sharing Zouzounis’ information on Facebook, we received a call from Craig Smith of the HPD, warning that Aaron’s posts were in violation of California Penal Code 653.2 for “electronic harassment.” Aaron reached out to local civil rights attorney, Izaak Schwaiger, who said that “You’re not in violation of any statute. This is free speech.”

Officer Smith insisted that HPD “does not ‘monitor’ Facebook or other publicly viewable social media platforms.” This isn’t entirely accurate either. In early June, the Northern California Regional Intelligence Center, or NCRIC, was hacked. It’s one of 79 “fusion centers” where local and federal

cops and private businesses gather and share information.

Between May 25 and June 6, NCRIC sent bulk emails to 14,000 cops in the Bay Area, including twice-daily protest lists and FBI and DHS memos warning of violence, according to Micah Lee of the *Intercept*. Overall, about half of the bulk emails and most of the Suspicious Activity Reports were about the protests. Three were about threats against protesters. Nearly all involved monitoring social media and were disseminated through NCRIC’s counterterrorism officers.

Local cops can also request support from NCRIC. According to Lee, HPD posted a support request regarding a protest. This means they’re also receiving emails from NCRIC’s social media monitoring operation! In other words, they are monitoring social media. But the information they gather does not reflect real threats of crime or terrorism.

What can you do about this right now?


Contact District Attorney Jill Ravitch and urge her to prosecute Zouzounis and all other perpetrators of VRAs, and to drop charges against BLM protesters.

Contact your City Council or County Supervisor and demand that police and sheriff’s departments be prohibited from participating in NCRIC.

Attend or organize protests. Don’t let them win! But enlist vehicle accompaniment and be ready to document and publicize attacks. ✊



GLOBAL WARNING #3: Overpopulation and Greenhouse Gases

Recently global human population surpassed 7.8 billion (Worldometers.info), increasing at the remarkable rate of over 222,000 a day. China's population is over 1.44 billion, with India's more than 1.38 billion, expanding at 2.45 times China's rate and estimated to catch up in 7 years. Those two nations comprise 35% of our human species.

Human overpopulation, with our continuing industrial revolutions, is a force multiplier for all environmental problems on Earth. A quick calculation of per capita greenhouse gas (GHG) emissions by country shows that people who criticize China as the world's greatest emitter of GHG (and it is, at 28% of nations' emissions) fail to notice that the US produces 2½ times as much as China per person. And China, by the way, produces 2½ times that of India per capita.

Americans need to drastically reduce consumption. Government and bank subsidies of oil drilling, fracking and refinement need to be phased out and environmental protections strengthened.

Until recently, the US was the world's biggest GHG emitter and it is the largest cumulative emitter in history. Greenhouse gases are cumulative, building up in the atmosphere and oceans over time and being released into space over decades (methane), centuries and millennia (carbon dioxide – 20% of CO2 lingers for thousands of years).

While carbon and other GHG emissions have grown exponentially along with population growth, African nations, especially majority poor ones, have high population growth by percentage but are very low emitters compared to rich and more industrialized nations. Japan is declining in population. (It takes a reproduction rate of 2.1 to maintain the human species.) As the British Empire declined, its GHG contribution grew less, from over half of the world's carbon in 1882 to only 1% of world emissions today. The US Empire currently is at 15%, or 6.67 billion metric tons of CO2 equivalent in 2018 with only 4.2% of global population.

While every country needs to have a GHG and an overall pollution reduction plan (and stick to it), top emitters like China, the US, the European Union, India and Russia, with a combined 65% of GHG production, must take the lead. The US Environmental 'Destruction' Agency needs to rebrand yet again and actually protect us. The US must not only rejoin the 197-member Paris Accords, but needs to collectively forge an international policy

with teeth. Birth control must be accepted and encouraged.

From 1750 to 2020 the US has emitted 25% of total CO2, over the period beginning with the industrial revolution until now. This is much more than any other country historically. This is a function of population growth combined with wealth and industrialization, including massive transportation and military increases. The US military is the single greatest institutional GHG polluter on Earth.

China had a one-child policy in 1979 as part of a birth-planning program, as the country grew at an alarming rate. It was introduced after a decade-long two-child policy, with exceptions for rural families in need of farm help from their children and for some ethnic minorities. The policy carried penalties for violation and a small monthly monetary gift for compliance. It reverted back to the two-child policy in 2015, probably to rebalance the gender ratio. It has been estimated that 400-600 million births were averted in China during this period.

I used to have a business with a female partner in which we educated mostly youth about natural birth control methods. We lectured in schools and health centers and imported a PG-53 compact microscope from Barcelona for reading a woman's fertility cycle. It is worth considering that America and many other countries adopt a policy similar to China's, limiting births to a maximum of two per family. With the world's population at 7.8 billion and rising, a period of legislating one-child laws would reduce population more efficiently. Similarly, the enormous population of animals raised to be killed and eaten is an analogous area to consider. Raising large

families and eating large quantities of meat greatly degrades the environment.

Environmental Groups Oppose Senate Bill S.4431

From Sonoma County Climate Activist Network (SoCoCAN!)

Senators Dianne Feinstein (D-CA) and Steve Daines (R-MT) have co-authored a bill, S. 4431, the “Emergency Wildfire and Public Safety Act of 2020” which would increase wildfire risks to communities and ignore environmental laws.

Opposing organizations, including the Sierra Club, Center for Biological Diversity, Earthjustice, Natural Resources Defense Council and National Parks Conservation Association, collectively representing millions of Americans, are saying that rather than focusing on making our homes and communities safer, the bill would result in increased unregulated logging in areas far from communities.

Congress needs to directly support communities in hardening homes and creating defensible space, rather than spending hundreds of millions for increased logging efforts – which have exacerbated recent fires in the West in areas where clear-cutting and thinning operations have removed the largest, most fire-resistant trees.

S. 4431 is calling for more biomass energy production, which spews carbon dioxide and

other toxic byproducts into the air by the ton. This bill completely ignores the value of forests as storehouses of carbon. Burning forest products in biomass plants is ineffective in protecting communities and forests during

It is not a climate solution, will cause heavy increases in carbon released into the atmosphere and will drastically reduce the ability of forests to store and sequester carbon. The top fire scientists have shown us that we need

Understatement of the year: COVID19 has forced many businesses to redefine themselves, to pivot or sink. Nowhere is this more true than for Sonoma County based Green Mary.

For two decades Green Mary has reduced the climate change impact of events with zero-waste practices by greening public events around the San Francisco Bay Area. Currently there are no events, and public gatherings are unlikely for the rest of the year. Owner Mary Munat applied for and received the government's Paycheck Protection Program loan and has used it to morph from working at public events to being of public service, keeping 15 staff and herself busy and contributing.

Munat and her staff have been working around the Bay Area with many organizations and area nonprofits since March. They have worked

with Clean River Alliance paddling up our inland waterways to clean our inland waterways and riverbanks clear of debris using zero-waste methods. In normal times, Clean River Alliance welcomes volunteers, so if you are interested, go to www.cleanriveralliance.org. During the pandemic, things have ratcheted down a bit more.

Green Mary has expanded services to include food rescue and redistribution. Working with Sonoma Food Runners, they use their big, bright box truck to move food from resource centers to distribution centers such as the Sam Jones homeless shelter, St. Vincent de Paul's kitchen, Los Guilicos Camp, COTS and more. If you want to get involved with this vital organization, go to www.sonomafoodrunners.org.

Green Mary's crew are also working with the Berkeley Free Clinic to distribute water twice weekly to five homeless camps in Oakland and Berkeley for drinking and hand sanitizing stations. Now, with a truck-mounted water tank, Munat is tapping into other needed hydration services, from the water-starved elk in the Pt. Reyes National Seashore to firefighters and homeless camps. Keeping people hydrated without relying on single-use water bottles has long been a major thrust of this green business.

Currently a for-profit business, with their previously much-in-demand services paid for by special events and municipalities, Munat is now considering starting a non-profit division to continue the work that is so essential to people, organizations and the environment in the region. Mary stated, “When your primary purpose is to be of purpose, you find other ways to support and move ahead collectively. If you want us to work with your organization, visit the website www.GreenMary.com for our contact information.” Green Mary is living proof of the old adage, “When the world gives you lemons, you make lemonade.” ☘

this is what we have come to expect?





